The above named volunteer, and if a minor, the legal guardian of the above named volunteer, by his/her signature below, does hereby freely, voluntarily and without duress release and forever discharge, waive and hold harmless Habitat for Humanity International, a non-profit organization, and Habitat for Humanity of Glynn County, GA, Inc., a non-profit organization, their employees, directors and officers from any and all liability, claims and demands of whatever nature, either in law or in equity, with respect to any bodily injury or personal injury, illness, death or property damage which may hereafter arise from the Volunteer's activities with Habitat, whether caused by the negligence of Habitat or its employees, directors or officers, working at a Habitat building site, in Habitat's warehouse facilities, being transported in a Habitat vehicle or living in a Habitat house provided by volunteers. The Volunteer and Guardian also understand that Habitat assumes no responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health or disability insurance in any event of injury or illness and in fact **does not carry or maintain health, medical or disability insurance for any volunteer**. The Volunteer and Guardian do hereby release and forever discharge Habitat from any claim whatsoever which may hereafter arise on account of any first aid, treatment or service rendered in connection with the Volunteer's activities with Habitat or the decision by any Habitat representative to exercise the power of consent to medical or dental treatment. The Volunteer and Guardian hereby expressly and specifically assume the risk of injury or harm in the activities of Habitat and releases Habitat from all liabilities.

The Volunteer and Guardian do hereby also grant and convey to Habitat all rights, title and interest in any photographic images and video and audio recordings made during the Volunteer's activities with Habitat, including but not limited to any royalties, proceeds or other benefits derived from such photos or recordings.
